





As we mentioned last issue, the costs of printing and distribution are really becoming prohibitive. So we were faced with either don't communicate very much or be faced with rising costs. Many of you, or perhaps most of you, will be able to download your copy from the website. We will be sending you the link via an EJournal so that you can go directly to the Adobe Acrobat file and get (download) your own copy. If you still want to receive a printed copy, we have decided to institute a subscription in order to cover costs. For the balance of this year it will be \$5 and starting with 2012 it will be \$10/year.

We hope that the electronic version will offer a number of advantages to each of you and that there will be minimal need for subscriptions. The electronic version will allow you to print it directly... or download a copy and keep it on your computer.



Clearwater Yacht Club Provides Outstanding Speakers



The Florida Commodores Association held its 2011 Spring Membership Meeting, March 18th and 19th at the Clearwater Yacht Club in Clearwater Beach. The afternoon program featured two guest speakers; Brad Kendell, US Sailing Team Alphagraphics; and David Yates, Director of the Clearwater Marine Aquarium (CMA)

Brad Kendell, a Tampa, Florida Native, is a member of the Paralympic Alphagraphics which is managed by the United States Sailing Association (US Sailing), the national governing body for the sport of sailing and sailboat racing.

The top boats in each Olympic and Paralympic class are selected annually to be members of the US Sailing Team Alphagraphics. US Sailing supports these elite athletes with funding, coaching and training.

Brad is an extremely talented individual with an extensive resume of sailing achievements including;



As the US prepares its teams for the 2012 Olympic and Paralympic competitions in Weymouth, England, Brad will crew aboard a Sonar, an open three-person keel boat as a member of the US Sailing Paralympic team. Quite an honor and accomplishment, since the US Sailing Association supports only one crew and boat in this class!!!!

Brad spoke on various aspects of crewing in the Sonar, the individual sacrifices required for the competitiveness of racing as well as the physical conditioning and stamina required. Brad is an inspiration to everyone who knows him, heard him speak or followed his impressive accomplishments.

David Yates, former President of Ironman, joined the Clearwater Marine Aquarium approximately 6 years ago as its CEO. He assumed this position at a time when the aquarium was on the verge of insolvency. He created a vision, business model and a management team that has successfully resurrected the aquarium into a thriving organization.

The attraction is home to "Winter", a bottlenose dolphin that received an artificial tail after she was injured and rescued. When Winter came to the aquarium, David had the foresight to see her story of survival as an inspiration to others. He assembled a marketing and media plan that promoted the story worldwide and attracted the attention of animal lovers and others with disabilities that would learn from her story.
