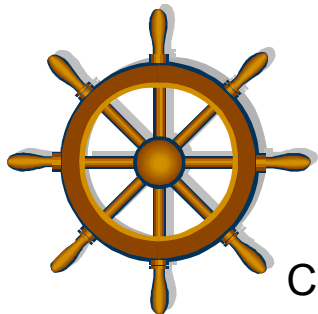

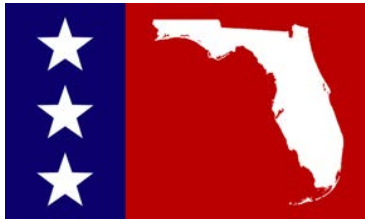

Chris Brown Named Four-Star Commodore



Christopher M. Brown, Past Commodore of the Halifax River Yacht Club has been named the 2011 Four-Star Commodore by the Florida Commodores Association. Past Commodore Brown is the first person to receive this honor.

P/C Brown joined the Halifax River Yacht Club in 1995 and moved up through the ranks, serving on the Board of Directors for three years, then as Secretary, Rear Commodore, Vice Commodore and in 2007 was elected Commodore.

Brown was involved with the planning and construction of the club's new facility from the very beginning. That beginning was made more difficult with the discovery of fuel tanks still filled and sitting in contaminated soil on the site of the new building. However, the completion of the new clubhouse was only part of the heavy lifting he accomplished as the old building was still in place and needed to be removed.

The old building was built on pilings over the water and the new building stood between it and dry land so everything had to be removed by barge. During the demolition, Brown endeavored to preserve as many "treasures" as possible so they formed the basis for the club's Hall of History. He also saved any lumber that could be reused, had it cleaned and stored for a future project he was to undertake.

Compounding the problem of removing the old clubhouse, after the building was removed, there were 40,000 cubic yards of debris under the water that needed to be removed in order to build a new center dock. After getting the debris removed, Brown undertook building the new dock with volunteers. Salvaging many of the pilings from the old building and using the lumber saved from that building, the combined savings in labor and materials resulted in a savings of several hundred thousand dollars.

The new clubhouse was opened only five weeks before Brown took the helm as Commodore adding the extra tasks of working out the kinks of a new larger facility with a larger staff. Over all these years of accomplishment he continued to run Chris Brown Marine, his boat repair business based in Ormond Beach.

P/C Brown is still active in many aspects of HRYC through committee work and is a member of the Halifax River Commodores Association and the local chapter of the Florida Commodores Association. He will be honored with the presentation of his Four-Star Award at the HRYC Commodores Ball on January 21.

Vice Commodore's Report

The Florida Commodores Association is about providing an important link among Florida Yacht Clubs and our mission statement emphasizes that; "To establish a community of Past Commodores who are members of recognized Florida Yacht Clubs, promoting Florida and international yachting customs and traditions through awareness, educational, charitable and social programs."



FCA will continue to focus awareness and support this next year for Olympic sailors Zach Railey who won a silver medal 2008 in Beijing, China and Brad Kendall who is a champion paralympian and are members of the USA Sailing Team for the 2012 Olympics. It is our hope and desire to provide awareness, through news media and yachting/boating communities, of the competitive sailors in the state of Florida.

If your Yacht Club, Community Sailing Center or organization has a competitive sailor you would like to recognize, send me the information, local media, Yacht Club, etc. and I will work with the Executive Committee to provide FCA recognition and organization awareness.

It is our goal to recognize individual Yacht Clubs and sailors for their contributions to the sport of sailing and the sailing community.

The 2012 FCA meeting schedule dates and Yacht Clubs have been confirmed and available on the FCA website. But, we will be wanting to set the 2013 schedule during this upcoming year. If you would like to showcase your club, please consider hosting an FCA membership meeting during the year of 2013. We plan on four (4) meetings : Winter, Spring, Summer and the Fall meeting being the Annual Meeting and Change of Watch at the Palm Coast Yacht Club. I will be glad to answer any questions you may have regarding the FCA host Yacht Club program.

As you know, the Florida Commodore's Association has chosen to support sailors from the State of Florida that are seeking to compete in the 2012 Summer Olympic Games in London. We have identified 3 highly competitive sailors including Zach Railey, a Finn Sailor, and his sister Paige, Laser Radial Sailor, and Brad Kendall who is a Paralympic Sailor, whose three-man team is part of the USSailing TeamAlphaGraphics still in competition for selection to the Paralympic Games.

This week we received terrific news that both Zach and Paige have been selected for the US Olympic Sailing Team and will compete in the 2012 Olympic Games. They both recently competed in the ISAF World Championships. Below are photos taken during the event. Zach is on the boat with USA 4.

Brad Kendell is a Florida sailor and member of US Sailing Alphagraphics Paralympic Team. He is another 2012 Olympic hopeful Sailing in the Sonar Class. Team.

Paralympic Sailing

Sailing was first introduced to the Paralympic Games in 1996 as a demonstration sport and became a medal sport for the 2000 Paralympic Games in Sydney.

Three boats will be raced at the 2008 Paralympic Games: the 2.4mR, a single-person keelboat, the SKUD-18, a two-person keelboat and the Sonar, a three-person keelboat. The high performance SKUD-18 makes its Paralympic debut this year in the coastal city of Qingdao, China. According to the International Foundation for Disabled Sailing (IFDS), a SKUD-18 team must include one female and one person deemed a Functional Classification System (FCS) "1," or severely disabled, like a quadriplegic. Sailors are seated on the centerline for Paralympic events, but the boat can be sailed with or without either of the seats and configured to suit different sailors' needs.

Because of its design and control, the 2.4mR was selected for single-person races. The boat's ease of use allows for a level playing field, making tactical knowledge the dominant factor in competition.

The Sonar uses a versatile crew-friendly design that is accommodating to athletes with physical disabilities. It is used by sailors of all experience and ability levels, from the novice to international competitors.

Paralympic sailing competition is open to male and female athletes with physical disabilities such as amputation/limb loss, blindness/visual impairment, spinal cord injury/wheelchair-users and cerebral palsy/brain injury/stroke.

The Florida Commodores Association is proud to announce a special recognition program for those Commodores who have taken that extra step. It is called the Four Star Commodores Award Program.

Each Past Commodore selected as a Four Star Commodore will receive a special award and a lapel pin to show that they have earned this special place among their peers. The award will be presented at your next Change of Watch or any other ceremony you designate.

Every qualified yacht club in Florida, even those without members in the Florida Commodores Association, is eligible to nominate a Past Commodore to receive this special designation.

Your Board of Directors/Governors could select a candidate or designate a committee to do so. You might even assign the honor to your Nominating Committee.

Your nominee could be a Past Commodore who did something special. For example he/she may have:

- Taken the lead or a major part in assisting your Club recover from a disaster such as a hurricane, a fire or a flood.

- Been the main person in guiding a Club through a major renovation or addition.

- Guided your Club through a major financial disaster.

- Been responsible for significant growth in your Clubs membership.

- Performed community service which brought distinction to your Club or any similar accomplishment.

Due to an overwhelming lack of interest the Recognition Contest will be terminated. The winner of the last contest was Carol Garside.

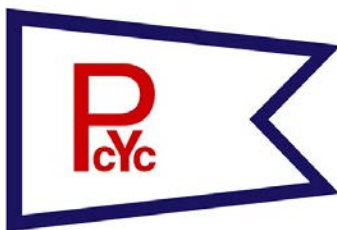

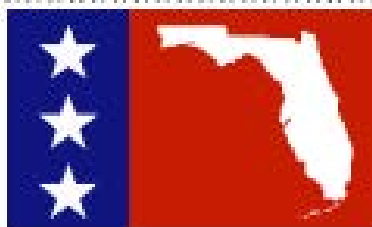
