Nautical Puzzler


Can any body tell me what a Froude number is? Why is it important to boating?

Answer

William Froude, who was born in 1810, was a pioneer hydraulic engineer. He was the first to realize that the resistance of water to boat motion was due to the waterline length more than the hull shape. Simply stated a boat makes a wave as it pushes into the water and the faster it goes the deeper the wave. If the wave comes up (next peak) under the boat everything is OK but if it comes up behind the boat then the boat is in a hole and trying to climb up a hill. The speed at which the boat finds itself in a hole is called the “hull speed” and it takes a lot of power to go faster than this. Hull speed, according to Froude, is $1.35 \times \sqrt{LWL}$ (the Water Line Length). Speed is in knots and LWL in feet. Obviously, the longer the boat, the bigger the wave that it can span.

This is why naval engineers use a model basin to test hull design. They scale the model to have the same Froude number as the full size boat they wish to study. In addition to wave resistance there is the viscous force of the water against the hull. That why sail boat designers talk about “wetted surface”. The less wetted surface the less viscous resistance to boat motion.

Finally we must point out that a planning hull, like a sport fisher or a speed boat, overcomes wave resistance by riding on top of the water being held up by water pushing up on the hull. If there are any waves already out there it can get pretty rough.

Regatta Safety Accountability Procedures

Vice Commodore Larry Kimmerling and Barbara his wife participated in a Youth Laser Midwinter Regatta at the Clearwater Sailing Center sponsored by their Clearwater Yacht Club. During this event they were impressed by the procedures used to identify and keep the safety of those participating in this event.

Competitors were issued a numbered identification safety bracelet which the participant is required to wear and make visible at all times while afloat except temporarily while changing clothes. Each morning the safety bracelet was collected from the Safety Committee table....and on returning from racing, the bracelet was required to be returned to the same location prior to the end of the protest filing time.

Each competitor was issued a numbered identification safety bracelet prior to getting underway on the water before the official start of every scheduled racing day, the competitor had to personally visit the Safety desk to “check-out” and put on his/her safety bracelet. As soon as practical but no later than the end of the protest time on every scheduled racing day, the competitor again needs to appear in person at the Safety desk to “check-out” and return his/her safety bracelet. Race officials will post the protest filing time, which is the wristband return deadline on the main bulletin board.

Generally speaking, volunteers view safety accountability as value added to any sailing competition. Safety accountability procedures permit identification of a registered sailor and emergency points of contact in the event of serious medical emergency. Procedures confirm the sailor’s daily on water status and his/her safe return to land.


While we cannot offer any legal opinion, we believe that this landside safety accountability program demonstrates due diligence to maintain sailor safety. In the event of any legal challenge to liability, the safety accountability program could become an important factor in the club’s favor to help reduce or eliminate potential liability.

The Four Star Award Program

2012 Four Star Commodore Nomination Guidelines

Purpose

This program distinguishes former Commodores of qualified Yacht Club in the State of Florida who have made contributions to their Club or on behalf of their Club beyond the normal duties and responsibilities of a Club Commodore. The award recognizes their commitment to continue to serve their Club and its members, to support the current leaders of the Club and to inspire their peers and future Club leaders.

Eligibility

All former Commodores of qualified Florida Yacht Clubs are eligible for consideration. Only one nomination may be submitted annually by each eligible Club. Posthumous nominations will not be considered. Membership in the Florida Commodores Association is not required. There is no cost to the Club or to their nominee.

Nomination Procedure

Each Club is free to decide how they will select a candidate for nomination. Upon selection the Nomination Form and all required documents must be submitted to the Florida Commodores Association (FCA) no later than September 30th..

Awards Procedure

Upon receipt of all Nominations the Awards Committee of FCA will review each Nomination submission for completeness and may disqualify a nomination if any required documentation is missing or incomplete. The Awards Committee will determine and recommend to the Executive Committee of FCA the names of finalists. The Awards Committee may require finalists to be interviewed by one or more Committee members. The Executive Committee of FCA will review the recommendations of the Awards Committee and make the final determination of those to be awarded the distinction of a Four Star Commodore. Up to three awards may be made in any one year.

Awards and Recognition

Those selected to be Four Star Commodores and their Clubs will be notified in writing prior to November 30. Each Award winner will receive a memento of their achievement and a special lapel pin to distinguish them as a Four Star Commodore. The Yacht Club of the Four Star Commodore will receive a framed certificate to display the achievement of their deserving Commodore. Awards will be presented by a member or members of the FCA Executive Committee at a ceremony or event to be selected by the Yacht Club of the Award recipients. In addition, each Four Star Commodore will be invited to be a guest of honor at the next regular meeting of the FCA.
