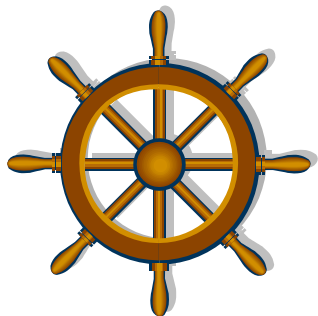

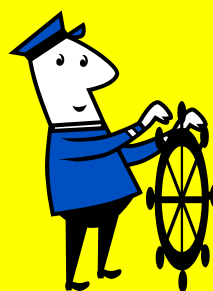

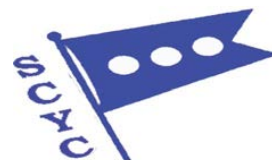

PENSACOLA YACHT CLUB CHAPTER UNDERTAKES A MAJOR PROJECT

Hurricane Ivan really did a job on the grounds of Pensacola Yacht Club. The front lawn had been the home to 8 large Naval Oak Trees that were over 100 years old. Ivan destroyed 4 of these magnificent trees. The remaining trees on the front and on the back side of the property suffered severe trauma and shock. Since Ivan PYC has lost at least 5 more trees on the property, the most recent the result of a major storm that devastated the Dauphin Island Regatta the weekend of April 25, 2015. Attempts to plant trees to restore those lost earlier had met with limited success because there was no water to keep the trees growing. In addition, the chapter had planted a memorial tree honoring one of our chapter members who had been very active in chapter activities. The tree died from the lack of water.

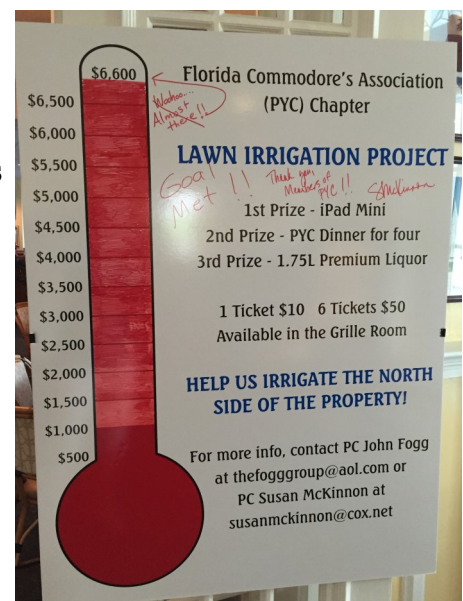


The PYC Chapter of FCA decided to do something to address this problem. After investigating the cost of installing a deep water well along with the beginnings of an irrigation system, we briefed the Commodore and board of Directors seeking their support for the project. They agreed wholeheartedly. So the following project was developed and support from the membership began on April 1, 2015.

PROJECT DESCRIPTION

The project will consist of installing a well on the property near the entrance along with the necessary controls, sprinklers and piping for two zones. It will provide water for the existing trees and plants and will enable additional plants and trees to be planted without the risk of dying from lack of water. Bids have been received and the estimated cost of the project is \$6600.

To attract attention to the project and show concrete evidence of the success of the solicitation of contributions, a "thermometer" was created showing the growth of the donations. By the time we started the campaign we had over \$1000 in the pot. Plans were to have the campaign last until July 4 when the drawing for three prizes including an Apple IPAD would be held. By April 24, we had received donations exceeding our goal of \$6600. The initial work to install the well and irrigation system has begun.



This is just an example of what an FCA Chapter can do to help their yacht club address problem areas. It takes planning, dedication, and commitment to make it happen. When executed properly, success is the outcome. It also shows the yacht club membership how valuable having their Past Commodores still involved in helping address and solve many of the problems facing the club while at the same time not being directly involved in "trying to run" the club.

WHAT DOES YOUR CHAPTER DO FOR YOUR YACHT CLUB?????

Proposed By Law Changes:

The Executive Committee has proposed the following changes to the FCA Bylaws. The changes are identified in RED below for the designated Articles, Sections, and Paragraphs of the By Laws.

ARTICLE III – ORGANIZATION

The FCA shall be composed of individual ~~Past Commodore~~ (delete) Members in good standing, approved Yacht Club Chapters (including Geographic Chapters) and the Executive Committee

ARTICLE IV – MEMBERSHIP

SECTION 1 – GENERAL MEMBERSHIPS – General Memberships are divided into two categories; Individual Memberships and Chapter Memberships. Membership in the FCA is by invitation only upon the recommendation of two FCA members.

Individual Membership:

~~A person eligible for individual membership must have been a~~ (delete)

Any Past Commodore of a recognized yacht club and who also meets any other requirements contained in the Bylaws of the FCA and who makes application to the FCA for membership shall be eligible for individual membership. Individuals are encouraged to join a local yacht club chapter but are not required to do so in order to have full membership privileges in the FCA. Only Past Commodores in good standing may be elected to office in the Association.

Any sitting Commodore or Vice Commodore of a recognized yacht club and who also meets any other requirements contained in the Bylaws of the FCA and who makes application to the FCA for membership shall be eligible for individual membership. However, these members are not eligible to hold elected office in the Association but are allowed to vote.

SECTION 2 – ASSOCIATE MEMBERSHIP – Membership in the Associate category is limited as follows:

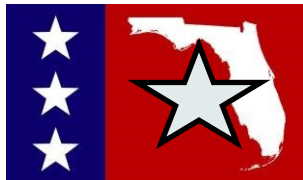
B. The current sitting ~~Commodore, Vice Commodore,~~ (delete) Rear Commodore and Fleet Captain of Recognized Yacht Clubs. (Add) Associate membership is valid only while in these positions.

D. An Associate Member in good standing may retain their membership in FCA as long as they maintain their membership in good standing with their original FCA Chapter. These members may not change yacht clubs or FCA Chapters and still retain their Associate Member status.

ARTICLE V – OFFICERS

SECTION 3 – ELECTION – Officers shall be nominated and elected and installed at the Annual Fall Meeting. Nominations for office may be made from the floor with the exception that the Vice Commodore will automatically advance to Commodore at the succeeding Fall Meeting or prior thereto in the event of death, incapacity or resignation of the Commodore. Only Past Commodores who are members in good standing of the Association are eligible to hold elected office in the Association.

These changes will be voted on at the General Membership meeting at Stuart Corinthian Yacht Club on Saturday, July 18, 2015.



FOUR STAR COMMODORES AWARD NOMINATION INFORMATION

Nomination documents for the fifth annual Four Star Commodores Award have been mailed to all Florida Yacht Clubs. The deadline for receipt of applications by the Four Star Award Committee is September 30.

Originated in 2011, this program recognizes former Commodores of qualified Yacht Clubs in the State of Florida who have made contributions to their Club beyond the normal duties and responsibilities of Club Commodore. Membership in the Florida Commodores Association is not required. There is no cost to the Club or to their nominee.

Those selected to be Four Star Commodores and their Clubs will be notified in writing prior to November 30. Each Award winner will receive a memento of their achievement and a special lapel pin. The Yacht Club of the Four Star Commodore will receive a framed certificate to display the achievement of their Commodore.

Awards will be presented by a member or members of the FCA Executive Committee at a ceremony or event to be selected by the Yacht Club of the Award recipient. Nomination information brochure is currently available on the Association website.
